- Secretary's Report Jamie Heying

- Treasurers Report Kim Holland
 - Current check book balance \$81,294.90
 - PLM pending invoice totaling \$27,761.21. Mike Raiche & Bill Ruddle are meeting with PLM on 7/22/15 to discuss: a) effectiveness of the treatments done; b) plans for 2016 & permitting; c) charges
 - Directory net \$1018.22 which is \$106 more than last year

 - Discussion regarding long term program
 - Greg Thomes is willing to set up a weed meeting with Legislators Bruce Anderson & Marion O'Neill to work on changing DNR permitting for weed management
 - o After the PLM invoice is paid, we have a \$2000 grant that will be reimbursed.

The DNR supervisor at Montrose should be able to help us get all of the reports. This is a lake assessment for fish. (Out of the Montrose fishery department of the DNR). This is done every few years.
