Board Minutes:

Secretary's Report: President Graham asked if there were any changes to the February Minutes, there were none.

Treasurer's Report: Bob Porter presented the Treasurer's report. For the period of February 1, 2020 thru February 28, 2020 is as follows: Beginning balance was \$45.473.86. Deposits were \$17, 765.66. Expenses were \$13,303.00. Ending balance is \$49,936.52.

A motion was made by Brian Peterson to accept the Treasury Report.

A 2nd was made by Mike Polencheck All were in favor, the motion carries

Membership Report: Tony updated the board on the following metrics:

- 1. 2019 -YTD 161 paid or 54%
- 2. 2018 159 properties paid or 53%
- 3. There are 296 applicable properties

Fishing Derby: Greg Thomes shared the he is finalizing financials for the 2020 Derby and will share the results with the Association at the next meeting. The numbers are obviously down from last year. Greg will be testifying to the House Commerce Committee at the State Capital on Friday. Currently, law states new entities cannot be granted a liquor license until after 3 years of operation. Greg's mission is to explain to lawmakers the Derby is only a new business on paper and has been in operation for several years dba the Maple Lake Property Owner's Association. This effort will hopefully secure a liquor license in the name of the Derby for 2021 contest. He indicated there are a few items to clean up on the ice (mainly wood frozen in the ice used to secure the tent). On a side note; Greg was contacted by Rhonda Pagel regarding a Maple Lake youth fishing league for students in grades 6-12. The league will fish Maple Lake and Ramsey lake. Currently, Pagle is looking for people who are interested in being a Boat Captain. Boat Captains will provide their boat and act as fishing guides and mentors for the students. If interested please contact Rhonda Pagel.

Mill Creek Dam/Lake Level: President Graham indicated there are trees and branches down in the outlet that will need to be addressed. He will meet with a contractor to discuss removing downed trees.

Water Quality Team: Tom Valenta shared that the ML-LPOA has been awarded two grants. One is for the control of Eurasian Water Milfoil and the other is for the control of Curley Pondweed. Both grants total approximately \$8,000. PLM is recommending we apply for permits to control 44 acres for milfoil and 11 acres

for curly weed. Both Tom and Ted Pribyl are speaking with both PLM and Lake Restoration on pricing for 2020. To cover the application costs, an additional 20k may be needed on top of the LID money in the proposed budget slotted for weed maintenance.

A motion was made by Betty Thomas to approve an additional 20k to be paid by the ML-LPOA general fund.

A 2nd was made by Brian Peterson All were in favor, the motion carries.

Maple Lake Parade: Tony shared that he has coordinated an ice house to be pulled behind Mike Polencheck's vehicle in the parade to promote the 2021 Derby.

Gambling Report: Angie Pribyl gave the report to the Board for February activity. Last month's profit was \$7,120 up from January's \$1,425.00 after allowable expenses have been satisfied. She was able to present a check to the Board in the sum of \$7,000.00 after donation was made to ML Youth Baseball. Angie noted that our percentage of tax has increased due to the increase of activity and the change of tax bracket to 27% vs 18%.
