LID: Tom mentioned that there is ongoing work with the attorney regarding representation.

Annual Meeting: Tony led a discussion around logistics and topics for the spring meeting planned for May 7th, the Location is TBD, however the High School is still considered a good location. Membership dues will stay the same, and not be increased this year. The ML Messenger handled the Directory printing well last year, we will stay with them for the 2022 edition as well. An early letter will go out to MLLPOA members to inform them of PLM offers and weed efforts on the lake this year. There are Board seats up for election this year, including Vice President- this will be covered in the letter as well.
